**25% scope 3 emissions** reduced by 2024. Together, achieving net zero in 2025.

Per assembly/manufacturing entity, a % of materials is defined to be locally sourced.

**20% of materials and products** sourced from renewable or recycled sources by 2030.

**90% of waste** generated by purchased products and services recycled by 2025.

TOP-25 suppliers for assembly / manufacturing entities and DC, conduct thorough human rights due diligence. To ensure adherence to international human rights standards and best practices by 2030.

Roll out training to help employees identify and tackle environmental purchasing risks.

## SUPPLIER PRACTICES

Prioritize vendors who embrace our principles and can prove that they've integrated similar standards in their supply chains.

Comply with relevant EU legislation and regulations regarding procurement.

Continue to communicate our Conflict Minerals Policy with suppliers to ensure compliance.

TOP-25 suppliers for assembly / manufacturing entities and DC, have signed our Code of Conduct and acknowledge our expectations on human rights, fair labor conditions, health and safety, and business ethics by 2025.

TOP-25 suppliers pay a living wage to all employees by 2030.

Plymovent's **Sustainable Supplier Evaluation Procedure** outlines our method for evaluating, monitoring, and supporting our suppliers.
It includes a supplier questionnaire used to understand their priorities and actions related to our policy objectives.

- For existing suppliers, we use the outcome of this questionnaire to see where we can make improvements, together.
- For new suppliers, we ask several candidates to fill out the questionnaire. We use the outcome to decide which supplier fits best with Plymovent's sustainable procurement ambitions.
